BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

Neighborhood Development Funds to Develop Louisville for expenses related to developing a

neighborhood plan for the Louisville Muhammad Ali International Airport neighborhoods.
