FOR FUNDING AND MARKETING FOR THE 19TH ANNUAL KENDUCKY DERBY (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$13,500~~ \$19,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$2,000 each from Districts 14 and 24; \$1,500 from District 25; \$1,000 each from Districts 2, 3, 6, 13, 14, and 15, and 21; ~~and~~ \$500 each from Districts ~~3, 9, 10, 17, 20, 21, and 22~~; and \$250 each from Districts 5 and 8; through the Office of Management and Budget, to Harbor House of Louisville, Inc. for funding and marketing for the 19th Annual KenDucky Derby.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
