\$100,000.00 for a new not-to-exceed amount of \$200,000.00, only \$100,000 of which shall be spent in Fiscal Year 2022-2023, for an amendment to the noncompetitively negotiated Professional Service Contract with Kentucky Community and Technical College System/University of Kentucky Community College System for Jefferson Community College for a mentor/internship program, for the Louisville Zoological Gardens' Boma (African Petting Zoo) and Australian Walkabout to interpret animal natural history, habitat preservation and African Culture for the public from July 1, 2021 through June 30, 2023.
