## LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** That the zoning of the property located at 969 Barret Avenue containing approximately 0.08 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 20ZONE0037, is hereby changed from R-5B Residential Two-Family to O-R Office Residential; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 20ZONE0037.

**SECTION II:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
