ORDINANCE NO. , SERIES 2022

AN ORDINANCE APPROPRIATING \$2,500 \$2,950 \$3,650 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,500 FROM DISTRICT 6; \$250 EACH FROM DISTRICTS 15, 21, AND 24; AND \$200 EACH FROM DISTRICTS 13 AND 23: THROUGH THE OFFICE OF MANAGEMENT AND BUDGET. TO PARISTOWN SALON, INC. FOR BAND FEES FOR THE PARISTOWN PROGRAMMING INITIATIVE CONCERT SERIES (AS AMENDED). SPONSORED BY: PRESIDENT JAMES AND COUNCIL MEMBERS TRIPLETT, FOX, GEORGE, FLOOD, AND PEDEN

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$2,500 \$2,950 \$3,650 from Neighborhood Development Funds in the

following manner: \$2,500 from District 6; \$250 each from Districts 15, 21, and 24; and \$200 each

from Districts 13 and 23; through the Office of Management and Budget, to Paristown Salon, Inc. for

band fees for the Paristown Programming Initiative Concert Series.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
