**WHEREAS,** the Revenue Commission published a Request for Proposal for a new tax system and, after receipt and evaluation of the publicly solicited proposals, executed a contract for that system with Fast Enterprises, LLC; and

WHEREAS, the Revenue Commission desired to move the system from an in-house based set of hardware to hosting on the Internet, thereby requiring a new contract for the system, and to provide for maintenance and support of same; and

WHEREAS, the Metro Council approved a Sole Source Contract to accomplish this and
