SECTION I: The Mayor is hereby authorized to execute and furnish all required documents							
including a memorandum of agreement, as may be required by KOHS for the furtherance of the							
above referenced project and to act as the authorized correspondent for said project.							
SECTION II: The Mayor is hereby authorized to accept up to \$1,072,341 from the KOHS to							
purchase and replace all 1,200 sets of expiring ballistic rifle plates.							
SECTION III: This Resolution shall become effective upon its passage and approval of							
otherwise becoming law.
