BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$2,000 \$3,500 \$10,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 8; \$1,000 each from Districts 7, 9, 10, and 26; and \$500 each from Districts 1, 2, 4, 6, 15, 21, and 25; and \$250 each from Districts 3 and 14, through the Office of Management and Budget, to Louisville Pride Foundation, Inc. for operational costs associated with the Louisville Pride Festival.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
