FOR REPAIR COSTS AT THE IROQUOIS PARK EQUINE AREA (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$10,000~~ \$12,000 \$19,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$10,000 from District 15; \$1,500 from District 25; and \$1,000 each from Districts 10, and 13, 14, 21, and 24; \$500 each from Districts 2, 3, 16, 19, and 22; \$250 each from Districts 8 and 17; through the Office of Management and Budget, to Equine Trail Advocates, Inc. for repair costs at the Iroquois Park Equine Area.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
