AN ORDER TO APPROVE A \$10,000 FAITHFUL PERFORMANCE BOND FOR JO-ANN FARMER IN HER CAPACITY AS CORONER FOR JEFFERSON COUNTY, KENTUCKY.

SPONSORED BY: COUNCIL PRESIDENT WINKLER

WHEREAS, in accordance with KRS 72.010, the Coroner shall execute a bond for the faithful performance of the duties of that office; and

WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government has determined that a \$10,000 Faithful Performance Bond is sufficient to insure the faithful performance of Jo-Ann Farmer in her capacity as Jefferson County Coroner.

NOW, THEREFORE, BE IT ORDERED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:

SECTION I: The Council approves the aforesaid bond in the stated amount for Jefferson County Coroner Jo-Ann Farmer and directs that the bond shall be filed with the Jefferson County Court Clerk.

SECTION II: This Order shall take effect upon its passage and approval.
