**WHEREAS**, the Legislative Council of the Louisville/Jefferson County Metro Government has determined that a \$10,000 Faithful Performance Bond is sufficient to insure the faithful performance of Queenie Averette in her capacity as County Judge/Executive of Jefferson County, Kentucky.

**NOW, THEREFORE, BE IT ORDERED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:**

**SECTION I:** The Council approves the aforesaid bond in the stated amount for Jefferson County Judge/Executive Queenie Averette and directs that the bonds shall be filed with the Jefferson County Court Clerk.

**SECTION II:** This Order shall take effect upon its passage and approval.
