BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$11,242.80 is hereby appropriated from District 16 Neighborhood Development Funds, to Public Works, for streetlights in the James T. Taylor/Jacob School neighborhood, including a five-year lease agreement with Louisville Gas and Electric Company.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
