WHEREAS, in accordance with KRS 70.020, the Sheriff is required to execute a bond for the faithful performance of the general duties of that office;

WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government ("Council") has determined that a \$10,000 Faithful Performance Bond is sufficient to insure the faithful performance of John E. Aubrey in his capacity as Jefferson County Sheriff;

WHEREAS, in accordance with KRS 134.230(1)(a), the Sheriff is required to execute a bond for the minimum sum of \$10,000 for the faithful performance of his duties to collect the county levy including the urban services district taxes;

WHEREAS, the Council has determined such bond should be in the amount of \$10,000 for John E. Aubrey, Sheriff of Jefferson County, Kentucky, to perform the aforesaid duties;

WHEREAS, in accordance with KRS 134.230(1)(b), the governing body may require the
