AN ORDINANCE APPROPRIATING ~~\$2,000~~ ~~\$5,250~~ \$10,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICTS 2, AND 4, AND 25; \$1,000 EACH FROM DISTRICTS 17, 19, AND 20; \$500 FROM DISTRICT 18; AND \$250 EACH FROM DISTRICTS 16 AND 19, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO MENTAL HEALTH LOU & YOU, INC. FOR SPEAKERS AND PERSONNEL COSTS FOR ITS MENTAL HEALTH SERIES HELD IN LIBRARIES WITHIN LOUISVILLE METRO (AS AMENDED).

SPONSORED BY: COUNCIL MEMBERS SHANKLIN, ARTHUR, PIAGENTINI, FOWLER, BATSHON, BENSON, PARKER, REED, AND PRESIDENT WINKLER

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$2,000~~ ~~\$5,250~~ **\$10,000** is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from Districts 2, and 4, and 25; \$1,000 each from Districts 17, 19, and 20; \$500 from District 18; and \$250 each from Districts 16 and 19, through the Office of Management and Budget, to Mental Health Lou & You, Inc. for speakers and personnel costs for its mental health series held in libraries within Louisville Metro.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
