ORDINANCE NO. , SERIES 2014 AN ORDINANCE APPROPRIATING **\$6,100** FROM \$6,500 NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2.000 FROM DISTRICT 9: \$1,200 FROM DISTRICT 8; \$1,000 FROM DISTRICT 4; \$500 FROM DISTRICT 10; \$300 EACH FROM DISTRICTS 15, 21, 25; \$200 FROM DISTRICTS 13, 16; \$100 EACH FROM DISTRICTS 20, 12, 1, 5, 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET. TO THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE FOR PROGRAMMING COSTS OF THE SIXTH ANNUAL BUY LOCAL FAIR 2014 (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,100 \$6,500 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$2,000 from District 9; \$1,200 from District 8; \$1,000 from District 4; \$500 from District 10; \$300 each from

Districts 15, 21, 25; \$200 from Districts 13, 16; \$100 each from Districts 20, 12, 1, 5, 23; through the Office of

Management and Budget, to the Louisville Independent Business Alliance for programming costs of the Sixth Annual Buy

Local Fair 2014.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No.

290, Series 2011.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
