ORDINANCE NO. . SERIES 2015 **APPROPRIATING** AN ORDINANCE \$30.000 NEIGHBORHOOD FROM DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$10.000 EACH FROM DISTRICTS 18, 17; \$9,500 FROM DISTRICT 18; \$2,000 FROM DISTRICT 7; \$1,000 EACH FROM DISTRICTS 19, 22, 16, 11, 8, 24; \$500 EACH FROM DISTRICTS 23, 14, 15, 13, 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE DUCHENNE RESEARCH, EDUCATION & MIRACLE FOUNDATION, INC. (DREAM FOUNDATION) FOR THE PURCHASE AND INSTALLATION OF A PLAYGROUND FULLY ACCESSIBLE TO DISABLED CHILDREN ON THE KOSAIR CHARITIES EAST CAMPUS (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$30,000 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$10,000 each from Districts 18, 17; <u>\$9,500 from District 18;</u> \$2,000 from District 7; \$1,000 each from Districts

19, 22, 16, 11, 8, 24; \$500 each from Districts 23, 14, 15, 13, 10; through the Office of Management and Budget, to the

Duchenne Research, Education & Miracle Foundation, Inc. (Dream Foundation) for the purchase and installation of a

playground fully accessible to disabled children on the Kosair Charities East Campus.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
