ORDINANCE NO. , SERIES 2015 AN ORDINANCE AMENDING ORDINANCE 160. NO. SERIES 2015 WHICH APPROPRIATED A TOTAL OF \$59.000 IN NEIGHBORHOOD DEVELOPMENT FUNDS. THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE CENTER FOR CONSTRUCT ACCESSIBLE LIVING. INC. FOR MATERIALS TO WHEELCHAIR ACCESSIBLE RAMPS, STAIR RAILINGS AND GRAB BARS, BY ADDING \$2,400 FROM DISTRICT 25 NEIGHBORHOOD DEVELOPMENT FUNDS FOR Α NEW TOTAL **APPROPRIATION OF \$61,400.**

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$2,400 is hereby appropriated from District 25 Neighborhood

Development Funds, by amending Ordinance No. 160, Series 2015, which appropriated a total of

\$59,000 in Neighborhood Development Funds, through the Office of Management and Budget, to the

Center for Accessible Living, Inc. for materials to construct wheelchair accessible ramps, stair railings

and grab bars, for a new total appropriation of \$61,400.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended

for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
