ORDINANCE NO, SERIES 2016 AN ORDINANCE AMENDING ORDINANCE NO. 215, SERIES 2015 BY ADDING \$400 FROM DISTRICT 8 NEIGHBORHOOD DEVELOPMENT FUNDS TO THE ALREADY APPROVED \$19,050 FOR A NEW TOTAL OF \$19,450; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE WAR AGAINST VIOLENCE CORPORATION FOR COSTS ASSOCIATED WITH THE "YOUTHALERT!" VIOLENCE PREVENTION/HEALTH COMMUNITY OUTREACH PROGRAM AT HIGHLAND MIDDLE SCHOOL. SPONSORED BY: Council Member Owen
BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$400 is hereby appropriated from District 8 Neighborhood Development
Funds, by amending Ordinance No. 215, Series 2015, which approved \$19,050 in funding, for a new
total of \$19,450; through the Office of Management and Budget, to the War Against Violence
Corporation for costs associated with the "YouthAlert!" Violence Prevention/Health Community
Outreach Program at Highland Middle School.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for
a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective
at the date of passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
