### ORDINANCE NO. \_\_\_\_\_, SERIES 2016

**AN ORDINANCE APPROPRIATING A TOTAL OF ~~\$20,500~~ \$20,000 FROM DISTRICT 24 NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$14,100 FROM DISTRICT 21; \$1,000 FROM DISTRICT 24; \$800 EACH FROM DISTRICTS 12, 13, 14; \$500 FROM DISTRICT 3; \$250 EACH FROM DISTRICTS 2, 8, 9, 15, 25, 26; \$200 EACH FROM DISTRICTS 1, 5; \$100 FROM DISTRICT 6; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO AMERICANA COMMUNITY CENTER, INC., FOR OPERATING EXPENSES SUCH AS SALARIES AND UTILITIES (As Amended).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$20,500~~ \$20,000 is hereby appropriated from District 24 Neighborhood Development Funds in the following manner: \$14,100 from District 21; \$1,000 from District 24; \$800 each from Districts 12, 13, 14; \$500 from District 3; \$250 each from Districts 2, 8, 9, 15, 25, 26; \$200 each from Districts 1, 5; \$100 from District 6; through the Office of Management and Budget, to Americana Community Center, Inc., for operating expenses such as salaries and utilities.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
