BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$14,500 \$15,500 \$16,750 is hereby appropriated from Neighborhood
Development Funds in the following manner: \$3,000 from Districts 14, 24 and 25; \$1,000 each from
Districts <u>12,</u> 2 and 15; \$500 each from Districts <u>7, 13,</u> 1, 17, 20, 21, 22, and 23; \$250 from Districts <u>3,</u>
5 and 8, through the Office of Management and Budget, to Shirley's Way, Inc. for expenses
associated with the Shirley's Way Financial Assistance program.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for
a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective
at the date of passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
