**WHEREAS**, the Kentucky General Assembly in 2009 enacted KRS 154.32-010 to 154.32-100 (the "Act") establishing the Kentucky Business Investment Program (the "KBI Program") for the purpose of encouraging the development and expansion of the service and technology industry in Kentucky; and

**WHEREAS**, the KBI Program provides state incentives to businesses which locate or expand in the Commonwealth, including regional or national headquarters, thus creating and preserving jobs for Kentuckians; and

**WHEREAS**, the KBI Program encourages local governments to participate in these incentives for businesses within their jurisdictions; and

WHEREAS, the Council finds that offering the local incentives authorized by KBI Program for the purpose of attracting and retaining businesses is in furtherance of the public purposes of Metro

and will benefit Metro by creating new sources of tax revenue for the support of the public services					
provided by Metro; and					
WHEREAS, Abilene TX Foods, Inc. applied for the benefits authorized under the KBI					
Program and, in Resolution No. 145, Series 2012, the Council approved the granting of local					
inducements to Abilene TX Foods, Inc.; and					
WHEREAS, the Council wishes to amend Section 1 of Resolution No. 145, Series 2012 to					
reflect that Abilene TX Foods, Inc. is now known as Louisville Processing & Cold Storage, Inc.;
