and Budget, to Louisville Independent Business Alliance, Inc. for program and operating expenses fo
he Eighth Annual Buy Local Fair to be held at the Louisville Water Tower Park.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for
a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective
at the date of passage of this Ordinance.
