### ORDINANCE NO. \_\_\_\_\_, SERIES 2016

**AN ORDINANCE APPROPRIATING ~~\$5,004~~ \$5,501 \$8,351 FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$3,751 FROM DISTRICT 17; \$1,000 FROM DISTRICT 16; \$850 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 24, 13, 14, 22; \$250 EACH FROM DISTRICTS 7, 5 AND 21; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LEARNING FOR LIFE LINCOLN CHAPTER INCORPORATED FOR PARTICIPANT FEES FOR JEFFERSON COUNTY PUBLIC SCHOOL STUDENTS AND THE NATIONAL LICENSE FEE. (AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,004~~ \$5,501 \$8,351 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$3,751 from District 17; \$1,000 from District 16; \$850 from District 6; \$500 each from Districts 24, 13, 14, 22; \$250 each from Districts 7, 5 and 21; through the Office of Management and Budget, to the Learning for Life Lincoln Chapter Incorporated for participant fees for Jefferson County Public School students and the national license fee.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
