| ORDINANCE NO, SERIES 2016 AN ORDINANCE APPROPRIATING A TOTAL OF \$35,035.72 \$13,250 \$14,750 FROM DISTRICT 8 NEIGHBORHOOD DEVELOPMENT FUNDS (NDF) AS FOLLOWS: \$5,000 FROM DISTRICT 8; \$1,500 FROM DISTRICT 21; \$1,000 EACH FROM DISTRICTS 4, 6, 9 AND 12; \$500 EACH FROM DISTRICTS 1, 2, 10, 13, 15, 25 AND 26; AND \$250 EACH FROM DISTRICTS 3, 5, AND 14, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET TO LOUISVILLE PRIDE FOUNDATION, INC. FOR ITS SECOND ANNUAL LOUISVILLE PRIDE FESTIVAL ON BARDSTOWN ROAD. | BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS: |
| SECTION I: The total amount of \$35,035.72 \$13,250 \$14,750 is hereby appropriated from Neighborhood |
| Development Funds (NDF) as follows: \$5,000 from District 8; \$1,500 from District 21; \$1,000 each from |
| Districts 4, 6, 9 and 12; \$500 each from Districts 1, 2, 10, 13, 15, 25 and 26; and \$250 each from Districts 3, 5 |
| and 14, through the Office of Management and Budget to Louisville Pride Foundation, Inc. for its second |
| annual Louisville Pride Festival on Sept. 17, 2016 at the 1000-1200 blocks of Bardstown Road. The event is |
| open to the public and will be the second annual festival at this location. The Louisville Pride Festival even |
| engages the broader community about conversations and celebration of our local LGBTQ community. |
| SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a |
| public purpose. |
| SECTION III: This Ordinance shall take effect upon its passage and approval. |
