ORDINANCE NO. , SERIES 2016 AN ORDINANCE APPROPRIATING \$10,950 \$12,450 \$19,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3000 FROM DISTRICT 3: \$2,500 FROM DISTRICT 20; \$2,000 EACH FROM DISTRICTS 3, 1, 20, 21; \$1,000 EACH FROM DISTRICTS 2 AND 25; \$750 FROM DISTRICT 5; \$700 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 5, 8, 9, 10, 11, 12, 16, 17, AND 22, 23, 24, AND 26 AND \$250 DISTRICTS 7, 10, 13 AND 15; THROUGH THE FROM OFFICE EACH OF MANAGEMENT AND BUDGET. TO UNITED NATIONS ASSOCIATION OF THE UNITED STATES OF AMERICA KENTUCKY DIVISION, LTD. FOR PROGRAMMING EXPENSES THE HUMAN ASSOCIATED WITH CONDUCTING TRAFFICKING CONFERENCE: LOCAL TO GLOBAL (AS AMENDED)

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$10,950 \$12,450 \$19,200 is hereby appropriated from the Neighborhood Development Funds in

the following manner: \$3,000 from District 3; \$2,500 from District 20; \$2,000 each from Districts 3, 1, 20, 21; \$1,000 each

from Districts 2 and 25; \$750 from District 5; \$700 from District 6; \$500 each from Districts 5, 8, 9, 10, 11, 12, 16, 17, and

22, 23, 24, and 26 and \$250 each from Districts 7, 10, 13 and 15; through the Office of Management and Budget, to

United Nations Association of the United States of America Kentucky Division, Ltd. For programming expenses

associated with conducting the Human Trafficking Conference: Local to Global.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
