ORDINANCE NO. , SERIES 2017 AN APPROPRIATING ORDINANCE \$9,000\$11,050\$14,300 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$6.000 DISTRICT 22; AND \$1,000 FROM DISTIRCT 25; \$500 EACH FROM FROM DISTRICTS 2, 4, 7, 10, 12, 13, 14, 15, 16, 17, 20, 25; \$300 FROM DISTRICT 1; AND \$250 EACH FROM DISTRICTS 3, 5, 6, 9, 21, 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO JUNIOR ACHIEVEMENT OF KENTUCKIANA, INC. FOR CURRICULUM MATERIALS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of <u>\$9,000</u><u>\$11,050</u>\$14,300 is hereby appropriated from the Neighborhood Development Funds in

the following manner: \$6,000 from District 22; and \$1,000 from District 25; \$500 each from Districts 2, 4, 7, 10, 12, 13,

14, 15, 16, 17, 20, 25; \$300 from District 1; and \$250 each from Districts 3, 5, 6, 9, 21, 23; through the Office of

Management and Budget, to Junior Achievement of Kentuckiana, Inc. for curriculum materials.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
