ORDINANCE NO. _____, SERIES 2017

AN ORDINANCE APPROPRIATING ~~\$7,500~~\$13,750~~\$16,250~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 from District 12; ~~\$1,500 FROM DISTRICT 25~~; \$1,000 each from districts ~~2, 3, 13, 14, 15~~; AND \$500 EACH from districtS ~~1, 6, 9, 10, 17, 20, 21, 22~~; AND \$250 EACH FROM DISTRICTS ~~4, 5, 7~~; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO HARBOR HOUSE OF LOUISVILLE, INC., FOR PROGRAM EXPENSES ASSOCIATED WITH THE 14TH ANNUAL KEN-DUCKY DERBY. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$7,500~~\$13,750~~\$16,250~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; ~~\$1,500 from District 25~~; \$1,000 each from Districts ~~2, 3, 13, 14, 15~~; and \$500 each from Districts ~~1, 6, 9, 10, 17, 20, 21, 22~~; and \$250 each from Districts ~~4, 5, 7~~; through the Office of Management and Budget, to Harbor House of Louisville, Inc., for program expenses associated with the 14th annual Ken-Ducky Derby.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
