ORDINANCE NO. . SERIES 2017 AN ORDINANCE APPROPRIATING \$5,100 \$6,300 IN NEIGHBORHOOD DEVELOPMENT \$1,000 FROM DISTRICT 15; \$500 FROM FUNDS IN THE FOLLOWING MANNER: DISTRICT 24; \$250 EACH FROM DISTRICTS 1, 3, 6, 7, 10, 12, 13, 14, 17, 18, 19, 20, 22, 23, AND 25, AND 26; AND \$200 EACH FROM DISTRICTS 2, 4, 5, AND 9; TO THE LOUISVILLE METRO FIRE DEPARTMENT FOR FUNDING FOR THE XXVII WORLD FIREFIGHTERS COMBAT CHALLENGE. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO **GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

SECTION I: The sum of \$5,100 \$6,300 is hereby appropriated from Neighborhood Development Funds in the

following manner: \$1,000 from District 15; \$500 from District 24; \$250 each from Districts 1, 3, 6, 7, 10, 12, 13, 14, 17,

18, 19, 20, 22, 23, and 25, and 26; and \$200 each from Districts 2, 4, 5, and 9; to the Louisville Metro Fire Department for

funding of the XXVII World Firefighters Combat Challenge.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public

purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
