WHEREAS, the Director of Louisville/Jefferson County Metro Government, Public Works Department has declared and certified to the Metro Council that the real property which is the subject of this Resolution is surplus to the needs of Metro Government (see Exhibit A attached hereto and made a part hereof); and

WHEREAS, Metro Government wishes to sell the real property which is the subject of this Resolution to Henry Ford, Jr. for \$500.00 subject to and in accordance with the terms and provisions of the Application to Purchase Property, a copy of which is attached hereto as Exhibit B.
