ORDINANCE NO. **SERIES 2018** AN APPROPRIATING ORDINANCE \$<del>6.250</del> \$12.750 FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$1000 EACH FROM DISTRICTS 4, 2, 9, 12, 15, 20, AND 22; \$500 EACH FROM DISTRICTS 1, 3, 5, 7, 10, 14, 16, 17, 23, 24, AND 25; \$250 FROM DISTRICT 13; THROUGH THE OFFICE OF AND BUDGET. WATERFRONT MANAGEMENT TO THE DEVELOPMENT CORPORATION FOR COSTS ASSOCIATED WITH THE LOUISVILLE WATERFRONT 4TH OF JULY (AS AMENDED). ## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$6,250 \$12,750 is hereby appropriated from Neighborhood Development

Funds, in the following manner: \$1000 each from Districts 4, 2, 9, 12, 15, 20, and 22; \$500 each

from Districts 1, 3, 5, 7, 10, 14, 16, 17, 23, 24, and 25; \$250 from District 13; through the Office of

Management and Budget, to the Waterfront Development Corporation for costs associated with the

Louisville Waterfront 4<sup>th</sup> of July.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for

a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
