**SECTION I:** That the zoning of the property located at 1749 Frankfort Avenue containing 0.07 acres and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 18ZONE1038, is hereby changed from R-5B Residential Two-Family to C-1 Commercial; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 18ZONE1038- with Binding Element #5 amended as follows:

The subject property shall only be used for office uses allowed in the C-R C-1 Commercial zoning district unless a change in use to a another use allowed in C-1 Commercial zoning district is approved by both the Louisville Planning Commission and the Louisville Metro Council.
