ORDINANCE NO, SERIES 2019 AN ORDINANCE APPROPRIATING \$2,000 \$8,150 \$11,300 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 \$4,000 FROM DISTRICT 22; \$1,000 EACH FROM DISTRICTS 4 AND 19; \$500 EACH FROM DISTRICTS 1, 16, AND 21, 25, AND 26; \$300 FROM DISTRICT 14; \$250 EACH FROM DISTRICTS 2, 3, 6, 12, 13, 15, 16, 17, 20, AND 23; AND \$100 FROM DISTRICT 3; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO JUNIOR ACHIEVEMENT OF KENTUCKIANA, INC. FOR CURRICULUM MATERIALS (AS AMENDED). BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$2,000 \$8,150 \$11,300 is hereby appropriated from the Neighborhood Development Funds in
the following manner: \$2,000 \$4,000 from District 22; \$1,000 each from Districts 4 and 19; \$500 each from Districts 1,
16, and 21, 25, and 26; \$300 from District 14; \$250 each from Districts 2, 3, 6, 12, 13, 15, 16, 17, 20, and 23; and \$100
from District 3; through the Office of Management and Budget, to Junior Achievement of Kentuckiana, Inc. for curriculum
materials.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
