ORDINANCE NO, SERIES 2019 AN ORDINANCE APPROPRIATING \$5,400 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 FROM DISTRICT 13; \$750 EACH FROM DISTRICTS 12, 15, AND 25; \$500 EACH FROM DISTRICTS 1, 3, AND 14; \$400 FROM DISTRICT 21; AND \$250 FROM DISTRICT 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. FOR OPERATING EXPENSES ASSOCIATED WITH ITS KEEP SOUTH LOUISVILLE WEIRD INITIATIVE AND PROGRAMMING EXPENSES ASSOCIATED WITH THE SOUTH POINTS BUY LOCAL FAIR. SPONSORED BY: COUNCIL MEMBERS FOX, GREEN, DORSEY, BLACKWELL, FOWLER, TRIPLETT, WINKLER, GEORGE, AND YATES			
BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:			
SECTION I: The sum of \$5,400 is hereby appropriated from Neighborhood Development Funds in			
the following manner: \$1,000 from District 13; \$750 each from Districts 12, 15, and 25; \$500 each			
from Districts 1, 3, and 14; \$400 from District 21; and \$250 from District 17; through the Office of			
Management and Budget, to the Louisville Independent Business Alliance, Inc. for operating			
expenses associated with its Keep South Louisville Weird initiative and programming expenses			
associated with the South Points Buy Local Fair.			
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for			
a public purpose.			
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective			
at the date of passage of this Ordinance.			
SECTION IV: This Ordinance shall take effect upon its passage and approval.
