ORDINANCE AN AMENDING ORDINANCE NO. **SERIES** ORDINANCE NO. 073, SERIES 2020 RELATING TO THE FISCAL YEAR 2020-2021 BUDGETS, OPERATING RESPECTIVELY, BY TRANSFERRING \$700,000 FROM THE LOUISVILLE FREE PUBLIC LIBRARY OPERATING BUDGET RELOCATION THE MIDDLETOWN LIBRARY PROJECT FOR EXPENSES RELATED TO CONSTRUCTION AND MATERIALS (AS AMENDED).
