### ORDINANCE NO. \_\_\_\_\_, SERIES 2021

AN ORDINANCE APPROPRIATING ~~\$8,500~~ \$11,500 \$16,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 12; \$2,500 EACH FROM DISTRICTS 13, AND 14, AND 25; AND \$1,000 EACH FROM DISTRICTS 15 AND 24; AND \$500 EACH FROM DISTRICTS 1, 6, 10, AND 21; THROUGH LOUISVILLE METRO PARKS, TO FUND THE ANNUAL RIVERVIEW INDEPENDENCE FESTIVAL, A FREE COMMUNITY EVENT, ON SATURDAY, JULY 3<sup>RD</sup>, 2021 AT RIVERVIEW PARK (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of ~~\$8,500~~ \$11,500 \$16,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$2,500 each from Districts 13, and 14, and 25; and \$1,000 each from Districts 15 and 24; and \$500 each from Districts 1, 6, 10, and 21; through Louisville Metro Parks, to fund the Annual Riverview Independence Festival, a free community event, on Saturday, July 3<sup>rd</sup>, 2021 at Riverview Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
