ORDINANCE NO, SERIES 2021 AN ORDINANCE APPROPRIATING \$8,500 \$11,500 \$16,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 12; \$2,500 EACH FROM DISTRICTS 13, AND 14, AND 25; AND \$1,000 EACH FROM DISTRICTS 15 AND 24; AND \$500 EACH FROM DISTRICTS 1 6, 10, AND 21; THROUGH LOUISVILLE METRO PARKS, TO FUND THE ANNUAL RIVERVIEW INDEPENDENCE FESTIVAL, A FREE COMMUNITY EVENT, ON SATURDAY, JULY 3 RD , 2021 AT RIVERVIEW PARK (AS AMENDED). SPONSORED BY: COUNCIL MEMBERS BLACKWELL, FOX, FOWLER, TRIPLETT MULVIHILL, HOLTON STEWART, FLOOD, GREEN, GEORGE, AND PRESIDENT JAMES
BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:
SECTION I: The sum of \$8,500 \$11,500 \$16,500 is hereby appropriated from Neighborhood
Development Funds in the following manner: \$5,000 from District 12; \$2,500 <u>each from Districts 13</u>
and 14 <u>, and 25; and</u> \$1,000 <u>each f</u> rom District <u>s</u> 15 <u> and 24; and \$500 each from Districts 1, 6, 10, and</u>
21; through Louisville Metro Parks, to fund the Annual Riverview Independence Festival, a free
community event, on Saturday, July 3 rd , 2021 at Riverview Park.
SECTION II: The Council has determined the funds requested in this Ordinance will be
expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and
effective at the date of passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
