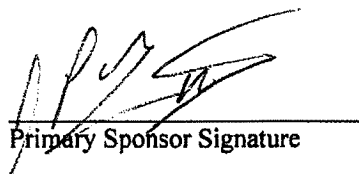

Describe Agency's Vision, Mission and Services:

Bridge Kids International (BKI) uses the power of African heritage (Black) culture to support the wellbeing of young people by engaging them, their families, and the community at large in programs that nurture creative confidence and promote economic development, education, the environment, girls' rights, and health. In addition, BKI links African, African-American, Caribbean and other Diaspora groups for the purposes of friendship, cooperation, and individual and community empowerment. BKI envisions young people and communities that have the confidence, skills, tools and resources to develop creative solutions and thrive.

BKI's programs promote positive racial/ethnic/cultural and gender identity, empower young families, nurture creative confidence, foster self-determination in young people from birth to young adulthood, and facilitate intergenerational relationships. BKI offers the annual African Heritage Festival, 7 Generations African Heritage Culture Camp, STEM Club, urban ecology, and arts programs including sewing, woodworking with power tools, cooking, storytelling, photography, writing, visual art, music, dance and more. In addition, BKI leads the Kizazi Fund, a child-focused, culturally-based, community-centered system for generational wealth building in Black families. In June 2025 BKI opened Our Place at Ben Washer Park (OPBWP), a unique community gathering place centered around youth social entrepreneurship, cultural exploration, intergenerational relationships, and sustainable living. Located in the Limerick neighborhood, OPBWP houses two social enterprises -- Our Place Café featuring Nice Cream and Our Place Boutique -- to help fund the operations of the building and programs provided there.

The African Heritage Festival is a celebration of unity, culture, art and history across the African Diaspora. Held on August 21-22, 2025, the 10th annual African Heritage Festival is a joyous event for the whole family with great food, music, dance, sports, fashion, cultural demonstrations, children's activities, resources for healthy living and so much more. This exciting celebration of African, African-American, and Caribbean cultures is hosted by Bridge Kids International (BKI), Lou City & Racing Lou Foundation, the Kentucky Old School Sports Association (KOSSA), Play Cousins Collective (PCC) and the Metro Louisville Office for Immigrant Affairs. The African Heritage Festival is being organized by a dynamic team representing a variety of organizations, countries and backgrounds. The whole city will be invited to this unifying event.

Friday, August 21st will be a day of live performances at Ben Washer Park between 5th & 6th on W. Kentucky Street. The park is home to Our Place at Ben Washer Park, Bridge Kids International's headquarters and we look forward to developing the African Heritage Festival there for years to come. On Saturday, August 22nd Lou City & Racing Lou Foundation will host the African Heritage Festival International Tournament at Lynn Family & Sports Vision & Training Center. Organized by KOSSA, the tournament features teams from Louisville and at least 5 states, representing 20 countries of origin. A wide variety of cultural activities for all ages will round out the festival. Some additional highlights of the 2026 African Heritage Festival are:

Louisville's African Heritage Festival celebrates the African Diaspora, a wide range of cultural groups in the city, including African-Americans, Africans and Caribbeans. The populations of people from Africa and the Caribbean have been growing in Louisville. It is important to offer a warm welcome to our new neighbors, build positive relationships across established cultural groups, and educate the wider community about the increasing diversity of cultures in the city. While various groups may share neighborhoods, schools and workplaces, they do not always have an understanding and appreciation of one another's backgrounds and experiences. Some tensions have even been reported between African-Americans and new arrivals from Africa. The African-Heritage Festival provides a safe, positive environment for groups to work and play cooperatively and celebrate one another. Individual festivals and community events for African-Americans, Africans, and various Caribbean groups exist in the city, however, the African Heritage Festival is unique in that it is designed to bring all groups together to acknowledge and build common bonds. The African-Heritage Festival is a unifying event and stands proudly in the company of other annual cultural festivals in the city.

By August 22, 2026

Lou City & Racing Lou Foundation provides the venue for the soccer tournament and Saturday festival activities and hosts the youth soccer clinic.

Metro Louisville Office for Immigrant Affairs assists with planning and outreach to immigrant groups.

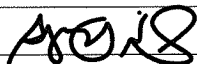

1. The name of the corporation is:

2. The corporation is a corporation as defined in subparagraph (a)(5) of section 102 of the Not-For-Profit Corporation Law.

3. The purposes for which the corporation is formed are:

To link youth of Africa and the African Diaspora for the purposes of friendship, cooperation, individual and community empowerment, implementing the idea of dynamic global citizenship. In order to accomplish these goals Bridge Kids International, Inc. will:

- Foster mutual respect, understanding, positive relationships and cooperation amongst youth of Africa and the African Diaspora;
- Inspire youth to be change agents for their own lives, their communities, and the world by helping them create simple and attainable solutions to challenges;
- Support youth-centered community development projects designed through international youth cooperation;
- Assist youth in obtaining the life, leadership and technical skills necessary to reach their project goals;
- Use technology to provide ongoing opportunities for communication and learning amongst the youth participants;



- Facilitate the sharing of history and culture amongst youth of Africa and the African Diaspora;
- Encourage youth advocacy;
- Organize international trips to support objectives;
- Provide channels to assist in the sharing of resources amongst organizations and individuals.

To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not the pecuniary profit or financial gain of its members, directors or officers, except as permitted under Article 5 of the Non-For-Profit Law.

4. In addition to the foregoing corporate purposes the corporation shall have all of the general powers set forth in Section 202 of the Not-For-Profit Corporation Law together with the power to solicit and receive grants, bequests and contribution for the corporate purposes.

Said Organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Nothing herein shall authorize the corporation to operate or maintain a nursery school, elementary school or secondary school.

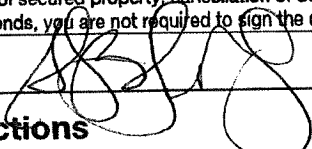
