ORDINANCE NO. 666, SERIES 2026**

AN ORDINANCE RELATING TO REQUESTING THE APPROVAL OF THE LOUISVILLE/JEFFERSON COUNTY METRO COUNCIL TO THE ANNEXATION BY THE CITY OF PROSPECT, KENTUCKY OF A TRACT OF LAND SITUATED APPROXIMATELY EAST OF HARRODS CREEK, WEST OF TIMBER RIDGE DRIVE, NORTH OF US HWY 42 AND SOUTH OF OHIO RIVER, JEFFERSON COUNTY, ADJOINING THE PRESENT CITY OF PROSPECT, KENTUCKY AND BEING ADJACENT TO AND CONTIGUOUS WITH THE PRESENT BOUNDARY OF THE CITY, AND IN THE UNINCORPORATED AREA OF THE FORMER COUNTY OF JEFFERSON

WHEREAS, the City of Prospect, Kentucky seeks to annex the following tracts of land which are not contiguous with the boundary of the former City of Louisville: and,

WHEREAS, pursuant to KRS 67C.111(3), a petition in favor of the proposed annexation has been signed by a number of registered and qualified voters residing in the area proposed to be annexed which is equal to at least seventy-five percent (75%) of the total number of votes cast in the area in the last preceding presidential election: and,

WHEREAS, The City of Prospect is ready and able to immediately begin furnishing municipal services to the area upon annexation of the area; and,

WHEREAS, KRS 67C.111(3) requires that the annexation receive the approval of the legislative council of the consolidated local government (the Louisville/Jefferson County Metro Council) prior to the City proceeding under the provisions of KRS Chapter 81A;

NOW THEREFORE IT IS ORDAINED BY THE CITY OF PROSPECT, KENTUCKY AS FOLLOWS:

Section 1. The City of Prospect hereby requests the approval of the Louisville/Jefferson County Metro Council of its proposed annexation of the certain property depicted in Exhibit A and more particularly described therein, which Exhibit is incorporated herein by reference as if set forth in full.

Section 2. The area proposed to be annexed, which is identified in Section 1, is adjacent and contiguous to the City of Prospect and is urban in character or suitable for urban purposes without unreasonable delay.

Section 3. A number of registered and qualified voters residing in the area proposed to be annexed which is equal to at least seventy-five percent (75%) of the total number of votes cast in the area in the last preceding presidential election have signed a petition in favor of the proposed annexation

Section 4. A copy of the petition signed by those in favor of the proposed annexation is attached as Exhibit B and incorporated herein by reference as if set forth in full.


Section 5. A list of the voters residing in the area proposed to be annexed who voted in the last preceding presidential election is attached as Exhibit C.

Section 6. This ordinance shall take effect upon its adoption and publication as required by law.
