The Men of Quality program operates year-round through a broad continuum of mentoring, enrichment, prevention, wellness and family engagement activities designed to strengthen both students and the communities surrounding them.

Our original Mission and Vision, as stated in 1996 was:

"For generations it has been the hope of parents, especially Black parents, that their offspring fare better than they themselves have. This includes educationally, spiritually, emotionally and financially. This is the American Dream. Yet, never before in the history of the country have our young people been more prone not to reach that dream. Our young people's minds are cluttered with stumbling blocks that are proving to be astronomical obstacles hindering the realization of the American Dream."

That statement was our vision in 1996 and it still stands today! Our mission is:

- Stand as professional educated Black Men as role models for young black males
- Conduct mentoring efforts for young black males
- Encourage self-esteem for our students
- Encourage positive life choices for our students
- Build student appreciation for academic achievement

Our headquarters is located at 2422 West Chestnut Street. We pledged when we purchased the building to uplift the neighborhood. Currently, we hold community meetings, youth sessions and community picnics.

Dear Applicant:

Based on information you supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

Because you are a newly created organization, we are not now making a final determination of your foundation status under section 509(a) of the Code. However, we have determined that you can reasonably expect to be a publicly supported organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

Accordingly, during an advance ruling period you will be treated as a publicly supported organization, and not as a private foundation. This advance ruling period begins and ends on the dates shown above.

If a return is required, it must be filed by the 15th day of the fifth month after the end of your annual accounting period. 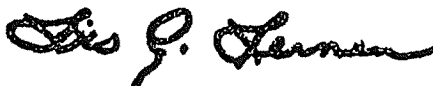

**ARTICLE I
Name**

The name of the corporation is Theta Omega, Inc.

**ARTICLE II
Purposes and Powers**

(A) The corporation is organized and operated for any lawful purpose including but not limited to, educational and civic purposes. In carrying out its corporate purposes, the corporation shall have all the powers allowed corporation by Chapter 273 of the Kentucky Revised Statutes.

(B) In furtherance of the general purposes in paragraph (A), the particular purpose of the corporation is: To improve the quality of life in Louisville/Jefferson County through community service and participation in the development of the area's socially disadvantaged young people.

**ARTICLE III
Directors**

ARTICLE IV **Limitation of Director Liability**

No director shall be personally liable to the corporation for monetary damages for breach of his duties as a director except for liability.

(A) For any transaction in which the director's personal financial interest is in conflict with the financial interests of the corporation;

(B) For acts or omissions not in good faith or which involve intentional misconduct or are known to the director to be a violation of law; or

(C) For any transaction from which the director derives an improper personal benefit.

If the Kentucky Revised Statutes are amended after approval of this article to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the corporation shall be deemed to be eliminated or limited by this provision to the fullest extent then permitted by the Kentucky Revised Statutes, as so amended. Any repeal or modification of this article shall not adversely affect any right of protection of a director of the corporation existing at the time of such repeal or modification.

ARTICLE V **Officers**

The bylaws shall identify and provide for the method of election or appointment of the officers of the corporation.

ARTICLE VI **Indemnification**

Each person who is or was a director, trustee, or officer of the corporation, whether elected or appointed, and each person who is or was serving at the request of the corporation as a member, director, trustee, or officer of another corporation, whether elected or appointed, including the heirs, executors, administrators, or estate of any such person, shall be indemnified by the corporation to the full amount against any liability, and the reasonable cost or expense (including attorney fees, monetary or

other judgments, fines, excise taxes, or penalties and amounts paid or to be paid in settlement) incurred by such person in such person's capacity as a member, director, trustee, officer, or employee or arising out of such person's status as a member, director, trustee, officer, or employee; provided, however, no such person shall be indemnified against any such liability, cost, or expense incurred in connection with any action, suite, or proceeding in which such person shall have been adjudged liable on the basis that personal benefit was improperly received by such person, or if such indemnification would be prohibited by law. Such right of indemnification shall be a contract right and shall include the right to be paid by the corporation the reasonable expenses incurred in defending any threatened or pending action, suit, or proceeding in advance of its final disposition; provided, however, that such advance payment of expenses shall be made only after delivery to the corporation of an undertaking by or on behalf of such person to repay all amounts so advanced if it shall be determined that such person is not entitled to such indemnification. Any repeal or modification of this article shall not affect any rights or obligations then existing. If any indemnification payment required by this article is not paid by the corporation within 90 days after a written claim has been received by the corporation, the member, director, trustee, officer, or employee may at any time thereafter bring suit against the corporation to recover the unpaid amount and, if successful in whole or in part, such person shall be entitled to be paid also the expenses of prosecuting such claim. The corporation may maintain insurance, at its own expense, to protect itself and any such person against any such liability, cost, or expense, whether or not the corporation would have the power to indemnify such person against such liability, cost or expense under the Kentucky Nonprofit Corporation Acts or under this article, but it shall not be obligated to do so. The indemnification provided by this article shall not be deemed exclusive of any other rights which those seeking indemnification may have or hereafter acquire under any bylaw, agreement, statute, vote of members or board of directors, or otherwise. If this article or any portion thereof shall be invalidated on any ground by any court of competent jurisdiction, then the corporation shall nevertheless indemnify each such person to the full extent permitted by any applicable portion of this article that shall not have been invalidated or by any other applicable law.
