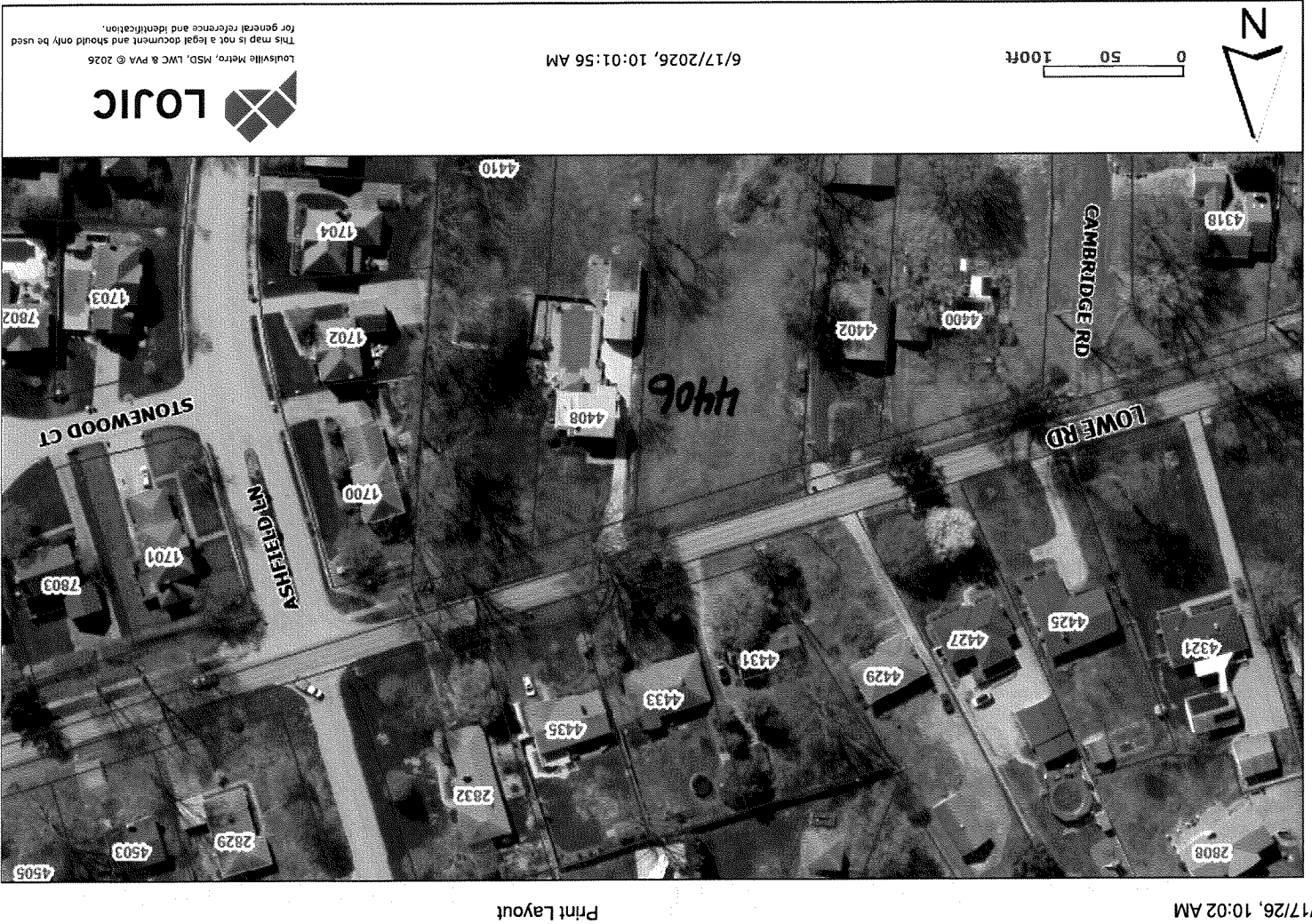

Dan,

Steve asked that I send a summary of my interaction with Jay Trautwein in September 2024 when I was preparing the estimate.

Jay and his mother (Linda) currently reside at 4408, and the Trautwein family is the only family that has lived in the home. I've known Jay for 30 years by way of my partnership in Birch, Trautwein and Mims. Ted Trautwein is Jay's uncle.

Jay is adamantly opposed to a sidewalk being constructed in front of their home. He does not think it is needed and has concerns about the impact the construction would have on a tree his grandfather planted fifty years ago. I don't agree with either of Jay's concern.

Jay went on to say that the Tasman family, who owns the property at 4406 Lowe Road, was also opposed to a sidewalk being constructed along the front of their property.

Nevertheless, the City of Cambridge has continually pushed for the construction of this sidewalk segment because it is the only unconstructed part of an important pedestrian connector to DePres Park. I think the City of Lincolnshire shares the same sentiment.

Metro has ample right-of-way to construct a five-foot-wide sidewalk and verge without much difficulty.

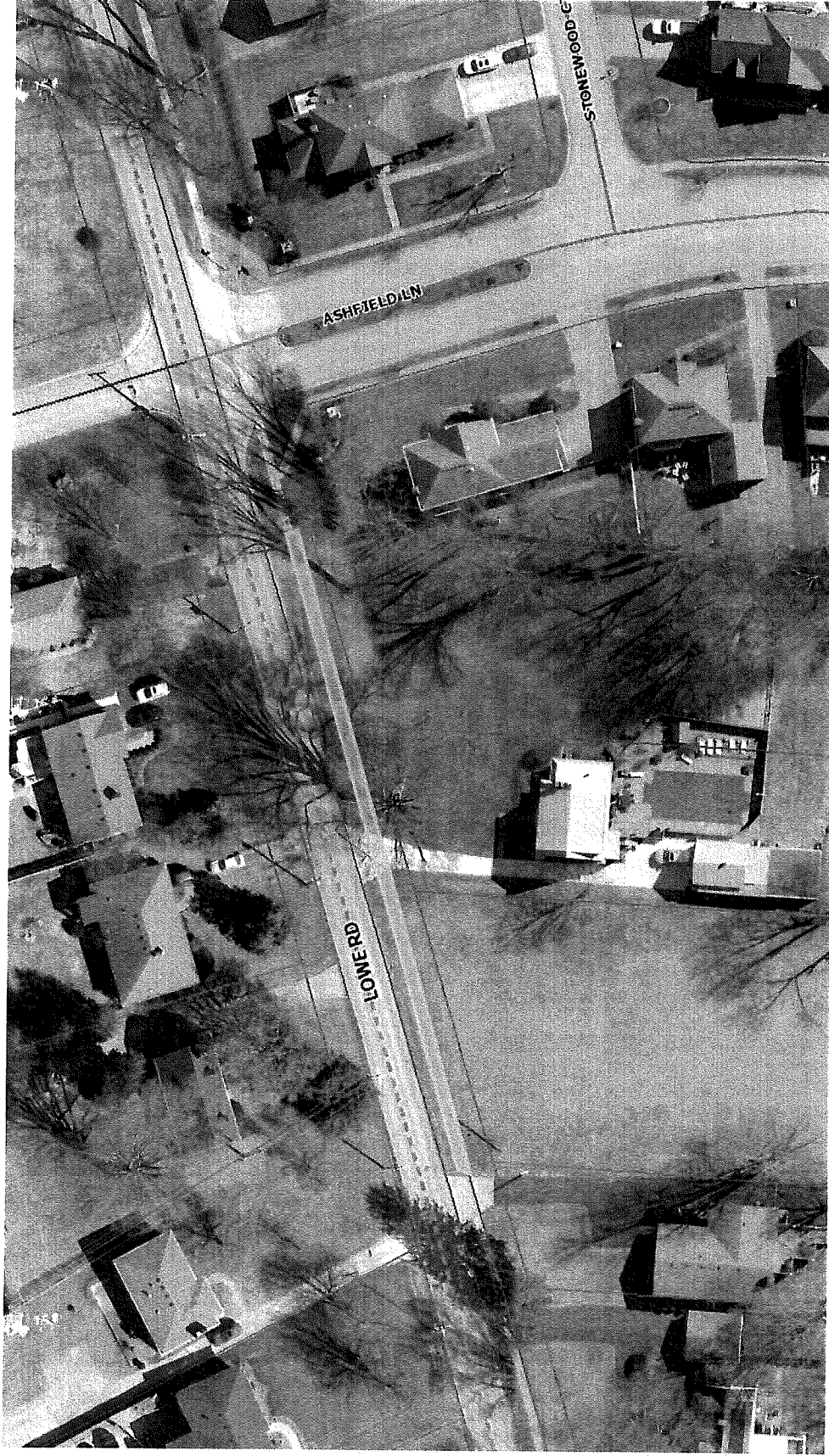

The necessary repairs will impact multiple locations and may involve private properties to ensure proper drainage. As a result, a full engineering plan will be required.

Hey Thierry,

Bobby and I reviewed and came to the conclusion that this is going to turn into a major project to get this water to drain correctly. The sidewalk is at a low point and due to minimal drainage, you will be chasing more issues by trying to raise to drain. The biggest culprit is 4706's driveway which is very high and blocking positive drainage to run down to CB @ 4708. We could possibly remove 75% of the driveway and get to function as intended, but would also require consent releases etc., and by the looks of it they probably would not want us on their property to tie back into the entrance of their garage. That work would also need to include regrading yards down to almost 4708. It doesn't hurt to try though.

We could install a drain, but that would include everything I mentioned, plus running pipe to 4708's CB (150'+).

If council is adamant, I would get Steve K to have an actual plan drawn up to get this area to function properly.

Let me know your thoughts.

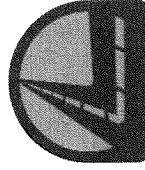

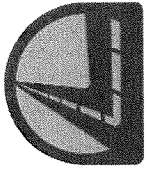

Based on the report below and our field inspection, the issue appears to be likely due to grading and drainage conditions.

To address it, we would recommend raising the sidewalk and installing a drain pipe beneath it to allow water to pass. Additionally, the yard may need to be regraded, or a yard drain installed to improve drainage and prevent water from pooling.

All,

I went by the site this afternoon. I also compared it to historical google street view imagery. There does not appear to be a water main leak and there is no leak registering at the meter. This section of sidewalk, and several others in this area, appear to have been installed to grade with little to no drop to the soil, so this exacerbates water and silt retention. The sidewalk is in good shape with no indication of significant cracking or settlement. There is limited drainage at the street side of 4704, with drain facilities appearing to be at the rear of the property. There is a catch basin at the front side between 4708 and 4710; however, the drain channel in the neighbor's driveway to the south appears to be at a higher elevation than 4704, so there's really no where for water to go in the current configuration. Regardless, with all the recent

rain, there was no standing water in the area. I'll have our leak surveyor check the area when he returns next week, but I don't expect he'll find anything either.

If there is no LWC issue, can the utility be inspected to determine no damage and the cap re-secured? At that point I will ask Public Works to inspect and determine a proper course of action.
