**AN ORDINANCE AMENDING ORDINANCE NO. 110, SERIES 2026,
RELATING TO THE FISCAL YEAR 2026-2027 OPERATING BUDGET,
BY REALLOCATING FUNDS BETWEEN VARIOUS DEPARTMENTS.
(AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE
LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“COUNCIL”) AS
FOLLOWS:**

SECTION I: Part I., B. Chief of Staff/General Counsel, 9. Office of Housing & Community Development, of Ordinance No. 110, Series 2026, is hereby amended as follows:

9. OFFICE OF HOUSING & COMMUNITY SERVICES

a. General Operations

e. Included in B. 9. a. (1) above is \$100,000 to Russell: A Place of Promise, \$500,000 for the OHCD Housing and Stabilization Fund, \$1,395,500 for Home Repairs, \$1,250,000 for down payment assistance, and \$1,000,000 to the Home of the Innocents, \$117,000 to St. John’s Center, \$87,500 to Family Scholar House, \$100,000 to United Partners for Women and Children, and \$50,000 to Exodus Ministries.

g. Any unexpended funds as of June 30, 2026 related to the Fiscal Year 2025-2026 appropriation for lawn maintenance for eligible District 1 residents may be carried forward for expenditure in Fiscal Year 2026-2027.

SECTION II: Part I., B. Chief of Staff/General Counsel, 13. Office of Violence Prevention, of Ordinance No. 110, Series 2026, is hereby amended as follows:
