Five (5) Speed humps x \$4200	=	\$21000
Four (4) Speed hump Signs x \$260	=	\$1040
Total	=	\$22040

Please consider this letter as our official statement of cost for all speed hump related work. Each speed hump, including markings, is \$4200 and each sign is \$260. Based on our engineering studies, a total of five (5) speed humps and four (4) speed hump signs have been proposed for Kenoak Dr, Alger Ave, Fay Ave from Arbor Ave to Kenwood Dr. The total "not to exceed" cost is \$22040. This statement of cost will be valid for 30 days.

Upon funding approval, the speed humps will be installed as schedule and weather permits.
