President Pro-Tem McCraney asked if Deputy Mayor David James would provide an update on the Youth Detention Center in regards to finances for the building and operations.

His update included:

- Testified to the Bill in Frankfort on February 15, 2023
- Building needs a new roof, HVAC system, plumbing repairs, fire system upgrades, and security and camera upgrades which will cost about \$8.9M
- Department of Juvenile Justice would run and operate the facility
- Having a youth detention center in the community would help with gang violence
- Metro Government will partner with state in providing the wrap-around services that will be needed
- Metro Government would not be responsible for financing the operation of the detention center, but money may be needed for the wrap-around services
