Trinity High School is requesting to provide student parking (assigned) at their existing tennis facility located on Sears Ave. The existing tennis center parking lot has been designed and constructed in compliance with all St. Matthews Land Development Code requirements and was fully approved in 2023. No additional parking spaces are proposed with this application. Relief is requested from 15.15.a which requires the parking to be within 200' of the buildings or property to be served. Due to the additional use of the parking lot for student parking, St. Matthews Planning and Zoning has requested that this application be an additional Conditional Use Permit for this property and not a modification of the original CUP.

Due to the availability of parking within a developed area such as St. Matthews, parking located off school grounds, on land owned by the school, and within easy walking distance justifies the request.

No new parking lot construction or any on-street parking are proposed in this application.

Dear Neighbor: We are writing to invite you to a meeting we have scheduled to present neighbors with our proposed Conditional Use Permit to allow Trinity to assign student parking in the existing tennis center parking lot in the OR-3 zoning district.

Accordingly, we filed a plan for pre-application review with the Louisville Metro Office of Planning. The applicant is proposing to use the existing 23 parking spaces (not including handicap spaces), located at the Sears Avenue tennis center as assigned parking spaces for students throughout the school year. The previous conditional use permit for the tennis center will remain intact and this application will be an addition to the approved uses for the site. 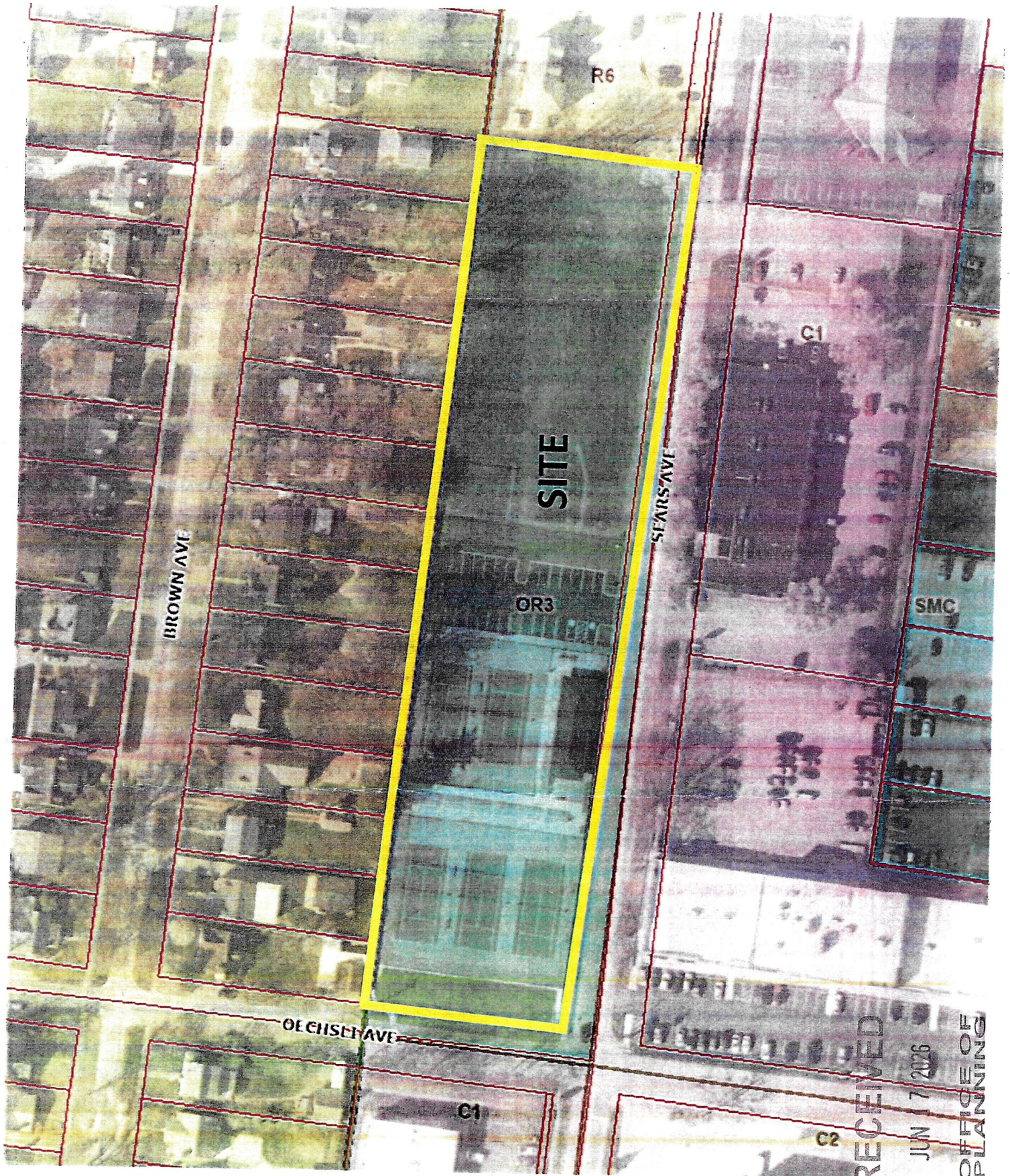
