I attach for the Board's information and records copies of the Jefferson County Clerk's filings concerning co-applicant Aeron Toney (Ms. Hite's designated local property manager) and two LLCs in which he is the principal. As you can see from the highlighted entries, he has been cited DOZENS of times for property and maintenance code violations over the course of many years, in one case even resulting in a demolition order. Not only is he is habitually cited on multiple properties over the course of many years for neglect, the clerk's records also note at least a couple of *lis pendens* actions as well as posting property for criminal bail. This, in addition to his preciously submitted criminal record, makes the many assurances in Ms. Hite's recent correspondence in the record about rigorous and competent management and oversight seem not only wishful thinking, but actively misleading.
