The Louisville Zoo Carousels requires a vendor that can provide certified parts, service, repairs, and maintenance for the antique Conservation Carousel. This shall include electrical and mechanical work for all components of the Carousel, wood finishing of any portion of the Carousel, painting of the wood structure and animals on the Carousel, and electronics servicing of the Carousel controls.

Vendor shall provide refurbishing service for existing animals on the Carousel, as well as new animals as replacements when requested by the Zoo.

JUSTIFICATION FOR NON-COMPETITIVE GOOD/SERVICE (Attach additional documentation if necessary)

Provide justification including but not limited to: a description of the unique features that prohibit competition; research conducted to verify the vendor as the only known source (sole source); why the service (PSC) is not feasible to be provided by LMG staff or expertise does not exist; known compatibility, proprietary and/or timing issues.

Todd Goings with Carousels and Carvings refurbished the Carousel and installed it at the Louisville Zoo. He is also the sole source for parts as his company bought the remaining parts, and molds for parts, from the Philadelphia Toboggan Company. The Zoo is required by Kentucky State law to use manufacturer provided parts for all of our Rides, and since Philadelphia Toboggan's Carousel division is no longer in business, Carousels and Carvings has all the parts and proprietary information to manufacture the parts needed for our Carousel.

The Louisville Zoo has typically bid this service in the past because there was another vendor in the United States that could have potentially done work on the Carousel, even if that company would have had to purchase the parts from Carousels and Carvings. That company was called Carousel Works, but they closed their business in 2020. The Zoo is unaware of any other company that has the certifications and capability to perform all the work needed on our Carousel.

AUTHORIZATIONS: Per KRS 45A.380, I have determined that competition is not feasible for the above described good / service and there is a single source within a reasonable geographical area of the good / service to be procured; or the resulting contract is for the services of a licensed professional, technician, artist, or other non-licensed professional service.
