AN ORDINANCE APPROPRIATING ~~\$8,000~~ ~~\$24,450~~ \$25,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$8,000 FROM DISTRICT 12; \$4,000 FROM DISTRICT 25; \$2,700 FROM DISTRICT 3; \$2,000 EACH FROM DISTRICTS 13 AND 14; \$1,000 EACH FROM DISTRICTS 1 AND 8; \$500 EACH FROM DISTRICTS 2, 5, 7, 9, 16, AND 22; \$300 FROM DISTRICT 19; AND \$250 EACH FROM DISTRICTS 4, 15, 17, AND 24; TO METRO PARKS FOR COSTS ASSOCIATED WITH THE RIVERVIEW INDEPENDENCE FESTIVAL TO BE HELD JUNE 27, 2026 (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$8,000~~ ~~\$24,450~~ \$25,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$8,000 from District 12; \$4,000 from District 25; \$2,700 from District 3; \$2,000 each from Districts 13 and 14; \$1,000 each from Districts 1 and 8; \$500 each from Districts 2, 5, 7, 9, 16, and 22; \$300 from District 19; and \$250 each from Districts 4, 15, 17, and 24; to Metro Parks for costs associated with the Riverview Independence Festival to be held June 27, 2026.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
