AN ORDINANCE APPROPRIATING ~~\$3,250~~ \$12,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,100 FROM DISTRICT 2; \$1,750 FROM DISTRICT 3; \$1,500 FROM DISTRICT 9; \$1,000 EACH FROM DISTRICTS 7 AND 8; AND \$750 FROM DISTRICT 15; \$500 EACH FROM DISTRICTS 12 AND 20; \$350 FROM DISTRICT 24; \$300 FROM DISTRICT 6; AND \$250 FROM DISTRICT 17; THROUGH THE OFFICE OF BUDGET AND MANAGEMENT, TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC, FOR COSTS ASSOCIATED WITH THE 2026 BUY LOCAL FAIR TO BE HELD MAY 31, 2026 (AS AMENDED).

SPONSORED BY: COUNCIL MEMBERS OWEN, RENO-WEBER, CHAPPELL, SHANKLIN, PARRISH-WRIGHT, MCCRANEY, JOSEPH, BENSON, MULVEY-WOOLRIDGE, LYNINGER, AND WINKLER

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:

**SECTION I:** The sum of ~~\$3,250~~ \$12,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,100 from District 2; \$1,750 from District 3; \$1,500 from District 9; \$1,000 each from Districts 7 and 8; and \$750 from District 15; \$500 each from Districts 12 and 20; \$350 from District 24; \$300 from District 6; and \$250 from District 17; through the Office of Management and Budget, to Louisville Independent Business Alliance, Inc., for costs associated with the 2026 Buy Local Fair to be held May 31, 2026.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
