Section I	33.01, 33.02, and 33.97	Electioneering: Definitions	Repeal	Redundant: KRS 117.235 and KRS 119.205 govern unlawful election practices.
Section I	33.03	Electioneering: Involuntary Political Contributions	Repeal	This section as written creates a Metro policy on campaign contributions. It has been moved under a new proposed section 39.003 (Metro Policies).
Section I	33.04	Electioneering: Severability	Repeal	Redundant: LMCO 10.08 covers severability of the entire Code.
Section II	37.10 to 37.19	Prevailing Wage	Repeal	Contrary to Law: preempted by state law. See KRS 65.016.
Section III	37.50	Financial Systems: Official Records	Amend	Obsolete: Corrects reference of Secretary of Finance & Administration to "Chief Financial Officer."
Section IV	37.53	Financial Systems: Purchasing and Contracts	Amend	Obsolete: Corrects reference of "Finance and Administration Cabinet" to "Office of Management & Budget."
Section V	37.75	Procurement: Taxpayer Subsidized Projects	Amend	Contrary to Law: removes references to prevailing wages that are preempted by state law. See KRS 65.016.
Section VI	38.01	Investment of Tax Revenues	Amend	Consistency with State Law: updates references of "shall" to "may" consistent with KRS 134.140. In 2009, the KY GA amended KRS 134.140 to make investment permissive instead of mandatory.
Section VII	39.003	Involuntary Political Contributions	Creates New Section	Moves LMCO 33.03 to this section of the Code.
Section VIII	39.179	Breonna's Law: Complaints and Discipline	Amend	Technical Correction: this section mistakenly states this section" when it should refer to "chapter."
Section XIII	39.224	Violations of Section	Amend	Technical Correction: refers to "this section" but intent is for covered entities in violation of LMCO 39.222 and 39.223.
Section XIV	41.04	Weapons in Metro Buildings: Signage	Amend	Technical Correction: updates Department responsible from "Department of Public Properties" to "Facilities & Fleet Management."
Section XV	43.01	Cemeteries: Permission to Enter	Repeal	Redundant: the authority to criminally charge already exists under KRS 511.070 and KRS 511.080.
Section XVI	43.02	Cemeteries: Restrictions; Prohibited Activities	Amend	Contrary to Law: (A) exceeds the scope of KRS 381.690.
Section XVII	43.03	Cemeteries: Defacing Cemetery Property	Repeal	Mostly Duplicates a crime already in KRS 525.115 but changes the elements in violation of law; repeal in favor of state statute.
Section XVIII	43.99	Cemeteries: Penalty	Amend	strikes LMCO 43.01 due to its removal in Section XV of the ordinance; needs updated to clarify penalties as civil or criminal; strikes reference to LMCO 43.03 due to its proposed repeal.
